LOG FILES POLICY AND COOKIES POLICY

Use of cookies

Cookies are small text files that are stored through the web browser, on the user's computer or other electronic device during his visit to a website and are retrieved on subsequent visits on the same website.

The cookies used by the Agency do not contain personal information, which could reveal the identity of the visitor to anyone. THE website operator uses only the cookies that are necessary for the operation of the individual websites.

The main function of cookies used by the Agency is memory information in order to identify the visitor when using the electronic services (connection to the site), any settings made by user for an application (eg language selection) as well as for production of statistical data aimed at improving the services provided.

Categories of cookies

In terms of their shelf life, cookies are divided into two categories:

- Session cookies, which are deleted immediately after closing browser,
- The permanent cookies, which remain in the browser for a certain for a period of time or until the user deletes them.

In terms of their usefulness, cookies are divided into the following categories:

- Technically necessary cookies, which are necessary in order to the electronic services of the Agency to function effectively, personalized information and not.
- Performance and analysis cookies, which are optionally used for

measuring traffic and time spent on the pages they provide information material, in order to improve the services provided.

In the electronic services of personalized information of the Agency, for entry where the visitor's personal credentials are required (TAXISNET codes or identification codes via "email"), only technically necessary cookies are used which are for the specific operation and with which the following are achieved:

- The connection of the user to the electronic services that require authentication or user safety,
- The recognition and / or retention of content entered by the user during duration of a session in an online service throughout its duration specific connection,
- The realization of the technique of load distribution (load balancing) in one link to a website of the website,

- Maintaining the user's choices regarding the presentation of a web page, e.g. select language, category, save search history,

The above mentioned cookies do not require the consent of the user, however the obligation to inform and refer the user to the Cookies Policy applies of the Agency.

The menus of most browsers provide options on how to manage "Cookies". Depending on options given to users by the browser, the user can allow the installation of "Cookies", to disable / delete the existing ones "Cookies" or be notified each time you receive "Cookies". Instructions for management and delete cookies are usually in the "Help", "Tools" or "Edit" menu of each browser. Also, the user can find more detailed guidance at www.youronlinechoices.com/gr, where is explained in detail the method for checking and deleting "Cookies" files in most navigation programs.

The user must take into account that, in case of rejection or deactivation the Cookies of the website, the functionality of the websites may be partially lost. Also, disabling a "Cookie" or a "Cookies" category the corresponding file from the browser is not deleted. Such an action must be performed by the user, modifying the internal functions of the browser in use.

The user when logging in to any online service / application of personalized information, is informed by a relevant reference at the bottom of the page about the use of cookies that are technically necessary for its operation.

Log files

When you visit the portal, some information is automatically collected from our server and are recorded in special log files.

The following items are recorded in the logs for each request to the server of the site from the visitor / user's browser: the IP address of the visitor / user, which is his personal data, even if we cannot identify the user on the basis of this evidence,

- the date and time of execution of each request for data transfer between browser and server (https request) for the operation of https protocol,
- the server response code along with the https protocol call parameters (https response),
- the server response time in ms to each request and
- the type of browser through which the request was made.

The above data is collected exclusively for the control of their security information and services of Hellenic Coast Guard, to ensure availability, integrity and confidentiality of information and data from random or illegal or malicious actions or incidents, to investigate any cyber-attacks and incidents and to support any relevant legal claims.

The purpose of storing this information is to control the security of the information and portal services, ensuring the ability to investigate any cyber-attacks and incidents and the support of any relevant liability claims.
